the administration of the Contest, the receipt or use of any prize, or any intellectual property rights infringement claims.

Personal information collected will be handled in accordance with the Municipal Freedom of Information and Protection of Privacy Act (MFIPPA) and as outlined in the Contest Rules.

- i. authorizes the Contest Sponsors to
